- · Scanned, signed copyright form has to be submitted along with the full paper and the signed hard copy should be submitted before the conference.
- Cover page should contain title of the paper, author(s) name and affiliation, contact details including mobile number and e-mail address.
- If the paper is co-authored by more than one, all the authors need to be registered individually.
