To provide theoretical knowledge before introducing the Applied Zoho CRM course, it is decided to introduce Customer Relationship Management in the Marketing Elective stream. Since Investment Banking is gaining more importance today and also providing more business opportunities, it is also decided to include Investment Banking Operations in the third semester. As the industrial expert, Mr.Lakshmi Narasimhan suggested to retain Industrial relations as HR's in both Manufacturing and Service are expected to have knowledge about Industrial relations, it is decided to introduce Industrial Relations as a separate elective.
